As I indicated in the letter of convocation, the Chapter will begin on July 5, 2022. In accordance with the Norms (art. 141 §1), and with the consent of the General Council, I establish that the conclusion of the Chapter will be approximately by July 24, 2022. We are confident that we will be able to celebrate the Chapter without particular difficulties due Covid-19; if they do occur, we will decide on what to do.

The Chapter event constitutes a new step in the journey of the Congregation, during which we are called to rekindle our consecration and mission in light of the charism. We want, therefore, to prepare ourselves adequately for this important appointment with personal participation.

We will do so through prayer, offering to the Lord our apostolic work and our daily sufferings, in order to implore the gift of the Spirit upon the Chapter assembly. As I already stated in the letter of convocation, each community will offer a Holy Mass each month for this intention and, in addition, at the community's discretion, to insert in the daily practices of piety the prayers that were sent for the above occasion.

Once the election of the Delegates has taken place, the Norms provide:

Art. 147: "2. After the election of the delegates, the Superior General, with the consent of the Council, appoints a Precapitular Commission to prepare the *Instrumentum laboris* for

the Chapter, on the basis of the draft prepared by the previous Committee. 3. When needed, let the help and advice of experts, even lay persons, be availed of. 4. The *Instrumentum laboris* will be sent to the Capitulars five months before the opening of the Chapter. 5. The Capitulars will send their amendments to the Committee within two months before the beginning of the Chapter to allow the Committee to draw up the final draft."

Our participation also calls for the contribution of reflection on the priority theme.

Finally, I recommend in particular that Chapter delegates combine their spiritual preparation with the specific preparation for the mandate they have received, through reflection, study, and discernment on the themes of the Chapter, in an attitude of listening to the Spirit, the signs of the times, and the feeling of the Confreres, as the Constitutions remind us: The Chapter members are accountable to the Church and to the Congregation; they prepare themselves adequately to discharge their office; they are animated by zeal for the development of the Institute, guided by an enlightened prudence in the study of problems and finding solutions, serenely free in expressing their opinions and judgments, always in fraternal charity. (Constitutions, art. 148).

May our Divine Superiors and the Patriarch Saint Joseph, special Patron of the Congregation, particularly in this year dedicated to him, bless and accompany this journey of preparation for the XIII General Chapter, through the intercession of our Founder, Saint Hannibal Mary, and of our other Patron Saints.
